### Sharing expertise

UCLA-LOSH advised the state agency on certification requirements for workers who handle lead and on best practices for providing workforce development to residents of underserved communities.

Other collaborators included the Los Angeles Trade Technical College, NATEC International, Inc., and Thermo Fisher Scientific.



Residents of communities affected by Exide were trained to conduct soil sampling and lead assessment. Some have already been hired.
