THIS IS A NOTICE OF INTENT AND NOT A REQUEST FOR QUOTATIONS.

The National Institute of Environmental Health Sciences (NIEHS), Research Triangle Park, NC intends to negotiate on a sole source basis with , ASTROPHYSICS, INC 21481 Ferrero PKWY City Of Industry, California 91789-5233.

This acquisition is conducted under the authority of 41 United States Code (U.S.C.) 1901 as set forth in Federal Acquisition Regulation (FAR) 13.106-1(b)(1)- Only One Responsible Source.

This purchase is for: A one-year maintenance and repair warranty from the manufacturer (Astrophysics). The warranty covers preventative maintenance, repairs, and labor costs associated with all malfunction repairs, failures to operate, and routine annual maintenance to include radiation survey.

PERIOD OF PERFORMANCE/DELIVERY: August 30, 2024 – August 29, 2025

The applicable North American Industry Classification System (NAICS) code for this acquisition is 811210 (Electronic and Precision Equipment Repair and Maintenance). The Small Business Administration (SBA) small business size standard for this NAICS code is \$34,000,000. Dollars.

NIEHS will solicit and negotiate directly with ASTROPHYSICS, INC and no solicitation will be issued. This notice of intent is not a request for competitive proposals or quotations; however, if an interested party believes they can meet the above requirement, it may submit a statement of capabilities. The statement of capabilities must be submitted in writing and must contain material in sufficient detail to allow the Government to determine if the party can perform the requirement.
