## Memorandum of Understanding Between AFGE Local 2923 and NIEHS External Awards

The Parties understand that this MOU covers external awards of Federal and non-Federally sponsored award programs that may be available to Agency employees. See appendix for listing of such awards, which is not all inclusive. This MOU covers any/all external awards that bargaining unit employees may be eligible.

This is the standard process for NIEHS regarding external awards.

- The NIH Workforce Services Division of Human Resources will notify the NIEHS Awards Coordinator of requests for nominations from an external source, along with any criteria for eligibility.
- 2) The Union shall normally be notified no less than two (2) business days in advance of sending the award to all employees; however, the notification shall preferably be sent sooner when practicable. Any notices less than 2 business days shall be accompanied with an explicit reason in writing as to why the Union was not notified in the normal timeframe.
- 3) The Awards Coordinator will send an all hands announcement asking for nominations.
- 4) When the award involves BUE's and when the Agency determines that they shall be involved in the selection and/or nomination regarding the award the Union shall be afforded at least the same number of Union representatives as management officials to offer comments and/or vote (if voting is used) on nominations or selectees that go forward.
- 5) The prioritized list will be sent to the Director.
- 6) All nominations will be sent to the nominee's supervisor and/or the Division Director.
- 7) The Director will select the nominees to be sent forward to NIH for review. Normally, and when applicable, the Director shall follow the recommendations/votes of those mentioned in #4 above but has the discretion to do otherwise. The Director's selections shall be sent to the Union at approximately the same time they are sent to NIH.
- 8) NIH will make a final selection and send the NIH Award nomination to the outside Requestor.
- 9) The Agency shall notify the nominee(s) of their nomination and whether or not they were selected. The Union shall be provided this information when it involves a BUE.
- 10) The Agency agrees to be fair and impartial in selecting the best qualified nominations to send forward to the NIH.

Nothing in this document changes or waives either party's rights.
